ANNUAL MEMBER'S MEETING JULY 15, 2023

In order to streamline the registration process of the Annual Member's Meeting, we have implemented the following to establish the necessary quorum, encourage Member participation and expedite the voting procedure as follows:

- There will be a registration table at the pavilion entrance. You will need to check in at this table upon arrival to verify your Member "In good standing" status. You will need to show a pictured ID. After your Member status has been verified, you will receive a wrist band to speed up the receiving of ballots.
- A hand-held microphone will be utilized for Member comments and /or questions. You will need to state your name and lot number prior to your comment and/or question. The microphone will be brought to you.
- 3) The Annual Member's Meeting will commence at 10:00 AM.
- 4) The meeting will be conducted in a professional and respectful manner in order to conclude the business of the meeting as efficiently as possible.
- 5) Once the business portion has been completed, voting will start.
- 6) You will show your wrist band to the Election Committee, receive your ballot(s) and cast your vote(s).
- 7) Members who do not attend Meet the Candidates or the Annual Member's Meeting or who arrive late will need to register with the Election Committee prior to receiving ballot(s).
- 8) The voting results will be announced after the ballots have been counted. Note: Members who have voted absentee are encouraged to attend the Annual Meeting and will be counted towards the quorum.



Voting

We have had some issues in the past at the Annual Members Meeting when it is time to vote. The problem is when the Member(s) name does not match the records in the office. The Office and Election Committee uses the name(s) that are on the official tax roll from the county. This can create a problem when (for example) spouses or co-owners names are not on the record and they show up to vote.

It is the PROPERTY OWNERS' RESPONSIBILITY to have the tax records updated with the names of those who may vote. Remember, each lot that Assessment fees are paid on results in one vote per lot and a picture ID is required.

To receive an Absentee Ballot, this application must be received AT THE POST OFFICE or be deposited in the locked Election box located in the Secretary/Treasurer's office during business hours BEFORE Thursday, June 29, 2023. No other application will be accepted.


In closing, I will continue to consider and respect the needs of the membership AND every single member when dealing with the various issues that come up from time to time.

My hubby Dan and I have lived in White Birch for 19 years and we both love this place and everything it has to offer. We wave to everyone that goes by our place. So enjoyable...



There is an abundance of information about Oak Wilt on the web. Just google it for more info. We *all* have to be pro-active to help control the spread of this disease. It is recommended not to cut oaks from April to July.

Dear Neighbors:

It seems hard to believe that I'm starting my fourth summer camping at White Birch. That first year, I had a lot with no good access, bought cheap on tax sale, and I knew absolutely nobody. Four years later I've met a lot of great people, made some friends, and have two lots not only with access, but also with electricity! White Birch has truly become my peaceful place.

I ran for a board position last year, and I did not do a good job of introducing myself to all of you – so I'm going to try to do better this time around. First, here's the resume items.
